

#TechHacks: Design Innovation Workshop #1

S/N	Summary of Discussion	Action by
1	Context Setting by Ministry of Communications and Information (MCI)	
1.1	MCI gave an overview of its approach towards digital well-being, and noted the importance and prevalence of the issue. MCI also shared their interest to partner with and thanked the #TechHacks panel for their interest to offer solutions and suggestions on digital well-being.	
1.2	<u>Q&A</u> Lee Kok Tong [Josh] (Member) asked about MCI's key challenge in addressing digital gaps. MCI noted that digital issues are often multi-dimensional in nature, and that digital well-being is a key focus area. Members queried on the details of online safety regulations overseen by MCI, and how citizens can play a part in them. MCI noted that the Online Safety (Miscellaneous Amendments) Act includes Code(s) of Practice for corporations and companies to ensure they take proactive measures to safeguard online content. The Code(s) of Practice also sets out community guidelines that are relevant to the local context. On enforcement, MCI highlighted to the panel that it would be important to recognise trade-offs. In addition to regulation, there is scope to give attention to other interventions, such as user education and empowerment (e.g., promote positive use, increase awareness of helpful tech tools). Ben Chua (Member) noted that online harms is a vast topic that has already been addressed through several areas (e.g., regulation, community), and sought MCI's clarification on where the #TechHacks panel might add value to. MCI noted that a multi-stakeholder collaborative effort is important in tackling online harms. They assured the panel that they are an important resource in contributing the youth perspective on tech and digital well-being.	
2	Introduction to Problem Definition & Analysis	
2.1	Priya Narayan (Verian) gave a recap on the topics covered at the earlier workshop on 18 November 2023: a. What is Public Policy? b. Agenda Setting c. Policy Formulation d. What happens after Policy Formulation. Amy Tan (Verian) shared on problem definition skills and introduced the Knowledge Audit (Known-Unknown) Matrix to the panel. Members divided into 3 groups to discuss the various sub-topics (details in Annex A).	
3	Introduction to Stakeholder Mapping	
3.1	Priya shared on Stakeholder Mapping and its importance to policymaking.	

	<p>Members conducted a preliminary stakeholder analysis on the following (details in Annex B):</p> <ul style="list-style-type: none"> a. Social media companies b. The government (MCI) c. Consumers <p>Priya encouraged the panel to also consider other stakeholders that may be engaged in addressing the problem statement, and the importance of seeking and engaging stakeholders' views in the policymaking process.</p>	
4	Problem Statement Discussion	
4.1	<p>Dev Bahl (Lead) shared the upcoming milestones for the panel, which includes an organic panel-level discussion in December 2023 to scope the problem statement, ahead of the next Design Innovation workshop in January 2024.</p> <p>Members further divided into 3 sub-groups to investigate the following (details in Annex C):</p> <ul style="list-style-type: none"> a. Digital Well-Being b. Digital Safety c. Digital Inclusion and Literacy <p><u>Digital Well-Being</u> Key issues include overconsumption, and the physical and psychological impacts of technology (e.g. myopia). Discussions include the importance of safe digital spaces (i.e., where users maintain a culture of respect, empathy, and humility). This includes how information is consumed, the application of regulation, and understanding the rules of engagement with technology in safeguarding well-being of youths.</p> <p><u>Digital Safety</u> Key issues include cyberbullying, doxing and sexual harassment. Key stakeholders include the Government, technological companies and end-users. Discussions include the need to improve current processes in reporting and handling malicious content, and the role of parents in educating children on online activities and interaction. Another area of interest includes personal responsibility, where users learn to be accountable for their actions online.</p> <p><u>Digital Inclusion and Literacy</u> Key issues include providing equitable access to technology. Key stakeholders include groups such as seniors and low-income families. Discussions include supporting seniors to overcome the “fear” of services going online, and to be more receptive and confident in using technology, as well as parental education among low-income families on digital footprint, the repercussions of over-exposure to digital tools, and unhealthy online behaviour.</p> <p>Dev noted there may be cross-cutting issues and encouraged members to discuss further in the coming weeks. Members also expressed interest to organise networking and fireside chats with existing contacts in the digital space, to keep discussions going in December.</p>	Leads and members to note
